

## **3 BASIC STEPS TO MAKING A BEQUEST**

**1. Decide to whom you want to leave a gift** Think about to whom and why you'd like to leave a gift. Maybe you or someone close to you has been greatly helped by a charitable organization. Maybe you're an active volunteer or believer in that group's mission and the work they're doing in the community. Or maybe you want to leave a gift in memory of a loved one - to his or her favorite charity - or for a specific use.

#### 2. Do your homework

If you are having trouble deciding or want to know more about a particular organization, do some investigating before leaving a gift. Call the nonprofit group directly and ask them about what they do, their mission, their fiscal health, and what opportunities are available for giving.

#### 3. Contact a professional advisor

Once you have determined to whom you'd like to leave a gift, contact your financial advisor (an attorney, financial planner, or accountant) for assistance. Your advisor will suggest what type of gift might best suit you, and can make sure you are getting the maximum tax and legal advantages you are allowed.


# GENERAL INFORMATION ABOUT LEGACY

GIFTS

- With planning, you can make sure your family is provided for AND leave an impactful gift to your favorite charity.

- You do not have to change your will to leave a bequest. You can simply add an amendment, called a codicil, to arrange for a gift upon your death.
- It is easy to name a charity to receive part or all of an IRA, a 401(k), or a life insurance policy.
- Your financial planner, attorney, or a development professional at your favorite charity would be

happy to answer your questions and assist you in carrying out your charitable intentions.

 Ask your financial planner about tax benefits available to you and your heirs through your bequest arrangements.

It's easy! The truth is that everyone can leave a bequest, no matter what your current income or assets may be, because bequests can be items other than money.
